### EMAP Celebrates 20 Years

### Regulatory Updates

#### DEP Accepting Comments on Enhancing Public Engagement

The Department of Environmental Protection announced proposed improvements to three policy documents focused on the development and review of regulations, interaction with Advisory Committees, and the development and publication of technical guidance. DEP secretary Patrick McDonnell stated, "These updated policies will provide a clearer path for the public to engage with DEP during the development of regulations and technical guidance documents." #### EPA Releases New Regulation Navigation Tools

The Environmental Protection Agency has released two additional online regulation navigation tools to assist facility owners and operators in assessing regulatory requirements. The new tools include the Portland Cement Manufacturing Industry and Brick & Structural Clay Products Manufacturing, to control air pollutants under the National Emissions Standards for Hazardous Air Pollutants. ## SBIR Phase I Solicitation Now Open

The EPA's Small Business Innovation Research (SBIR) Program is accepting Phase I Solicitation applications through December 19, 2017. The SBIR Program seeks to assist small businesses in developing and commercializing innovative technologies that address human health and environmental concerns. This year's topics include Clean and Safe Water, Air Quality, Land Revitalization, Homeland Security, Manufacturing, and Building Construction Materials. ## DEP to Cover Costs of Agricultural Plans for Clean Water

The Department of Environmental Protection has launched an Agricultural Plan Reimbursement Program for farmers in the Chesapeake Bay Watershed to cover costs of preparing agricultural plans developed after January 1, 2017. DEP aims to support farmers taking action to improve water quality by assisting with the costs associated with manure management, nutrient management, and erosion and sediment control plans. At least 800 and up to 2,200 plans will be covered under the program. Registration must be completed by April 1, 2018. ## ETAC Energy Services

The Emerging Technologies Applications Center (ETAC) has received grant funding through the US Department of Energy, State Energy Program, and the Department of Environmental Protection to assist manufacturers in reducing energy consumption and demand. ETAC offers simple walk-through analysis as well as full facility assessments and has assisted small businesses in obtaining utility rebates for energy conservation measures taken.
